The 6<sup>th</sup> BfR-Stakeholder Conference is to be held on November 18<sup>th</sup> 2016 under the heading "Scientific political consulting in the area of conflict between politics, science and the general public".

The event is to be dedicated to the question of which role scientific political consulting can and should play. If it wants to be scientifically upright, for example, should it see itself in the role of an "honest broker", who presents politics with all available scientific evidence in a well balanced way? To do so, the conditions under which scientific know-how can form the foundation of political decisions have to be identified along with whatever constraints there may be. In essence, it should be all about defining the role of scientific political consulting in and for society more precisely: What *should* it do and what *can* it do, as well as what *can it not* and what *should it not* do!
