

8th BfR User Conference on Product Notifications

The German Federal Institute for Risk Assessment (BfR) is the appointed body for the receipt and processing of product notifications used in the event of emergency health response in German poisons centres and for the assessment of reported poisoning cases in human according to the German Chemicals Act (ChemG).

The statutory basis for the notification obligation is provided by Art. 45 of the European CLP Regulation (EC) No 1272/2008, § 16e of the German Chemicals Act, Art. 9 of the European Regulation on Detergents, and § 10 of the German Detergent and Cleaning Agents Act.

The new Annex VIII to the CLP Regulation, entered into force by Regulation (EU) 2017/542, comprises a harmonised notification format for the submission of information on hazardous mixtures (products) to the appointed bodies of the EU member states. The format will harmonise notifications, regarding both content and technical format, within the member states in a legally binding way. According to the field of use of the mixtures concerned it is a stepwise process starting on EU level in 2020. As a result the notification requirements will alter and the amount of submissions will significantly increase, as the transitional provisions of the German Chemicals Act will expire at the same time. The BfR would like to inform on these imminent changes and would like to discuss the challenges associated with this process with all involved parties.

The User Conference addresses to all actors in Germany and in Europe especially of the industry, authorities and poisons centres.
