### BfR Symposium "Acting in Times of Crisis and Crisis Prevention" in cooperation with ANSES (France) and DTU (Denmark)

This internationally orientated event is being organised by the Federal Institute for Risk Assessment together with the French and Danish sister authorities ANSES and DTU. On both days of the event, experts from Germany and neighbouring European countries will deal with questions concerning responsibilities in the event of food safety crises, the role of the state and institutions, cooperation between authorities in times of crisis and stability, as well as the precautionary principle and instruments of crisis management and crisis prevention in the area of food safety.

As part of the above, differing political, economic, administrational and scientific perspectives in times of crisis will be presented and discussed. On the second day, social interest groups in particular shall debate possibilities of crisis prevention and institutional cooperation and consult on which alternatives make sense and which preventative measures are acceptable for making foodstuffs even safer.
